
### **Sources of County Revenues**

County governments and Baltimore City collected \$32.2 billion in revenues in fiscal 2019, excluding debt proceeds. County governments receive revenue from two basic sources: own-source revenues, which include locally generated revenues such as property taxes, income taxes, and service charges; and intergovernmental revenues, which include federal and State funding. Property taxes and State aid account for the leading revenue sources for county governments, followed by local income taxes and service charges.

#### **Local Own-source Revenues**

Own-source revenues consist of total revenues minus intergovernmental revenues. Own-source revenues as a percentage of total revenue show how dependent a jurisdiction is on its own-source revenues compared to intergovernmental revenues. A high ratio indicates that the local government has control over its revenues and is relatively fiscally self-reliant. While there is not a set percentage of intergovernmental revenue reliance to indicate a problem, counties with higher bond ratings tend to average about 50% of their revenue from their own sources. Statewide, own source revenues account for 66.4% of county revenues. The percentage ranges from 28.9% in Somerset County to 78.3% in Worcester County. Many of the State's less affluent iurisdictions receive a lower percentage of their funding from local sources and a higher percentage from the State and federal government.


#### State Aid to Local Governments

State aid is the largest revenue source for many county governments in Maryland, accounting for 26.8% of total revenues in fiscal 2019. The percentage ranges from 16.9% in Montgomery County to 60.7% in Somerset County.


In the 12 counties in which State aid was not the largest revenue source, it was either the second or third leading revenue source. In Anne Arundel, Baltimore, Calvert, Carroll, Garrett, Harford, Kent, Talbot, and Worcester counties, State aid was the second largest revenue source after property taxes, whereas in Howard, Montgomery, and Queen Anne's counties, State aid was the third largest revenue source after both property and income taxes.

State aid includes direct assistance to county governments, local school systems, libraries, community colleges, and local health departments. In fiscal 2019, local school systems received approximately 85% of total State aid. County and municipal governments received 9%, with a majority of the funds targeted for transportation and public safety initiatives. Community colleges, libraries, and local health departments accounted for the remaining 6%. Approximately 70% of State aid is distributed inversely to local wealth. Utilizing local wealth measures to distribute State aid attempts to offset the inequalities in the revenue capacity among local jurisdictions.

#### **Local Revenue Outlook**


County governments are projecting smaller increases and slower growth in local tax revenues in fiscal 2021 due to the impacts of the COVID-19 pandemic on the State economy. Income tax collections are negatively impacted by increased statewide unemployment, and other tax revenues decline as a result of decreased economic activity due to the pandemic. General fund revenues increase statewide by just 0.9% in fiscal 2021, and total local tax revenues increase by 1.6%. Not surprisingly, several jurisdictions indicated challenges for the fiscal 2021 budget cycle. For example, the annual change in local tax revenues in fiscal 2021 is estimated at 1% or less in five counties, with Queen Anne's County anticipating a decrease in tax revenues. A total of eight counties averaged growth of less than 1% or a decrease in annual local tax revenues between fiscal 2019 and 2021, with nearly half of counties at less than 2% growth.

Property taxes, however, remain fairly stable in many counties, and accounted for the largest percentage increase over the two-year period (fiscal 2019 to 2021) with revenue growth exceeding 3% statewide. Although income tax collections are projected to increase by 4.7% in fiscal 2020, reflecting strong wage growth and low unemployment before the start of the pandemic, growth slows to just 0.8% in fiscal 2021, for an average of 2.7% growth over the two-year period.


#### **General Fund Revenues**

General fund revenues for county governments are projected to total \$16.4 billion in fiscal 2021. Revenue amounts range from \$39.1 million in Somerset County to over \$3.5 billion in Montgomery County. On a per capita basis, the amount ranges from \$1,330 in Allegany County to \$3,908 in Worcester County, with the statewide average at \$2,720. General fund revenues (per capita) are the highest in Worcester, Calvert, Howard, Montgomery counties, and Baltimore City. The lowest per capita amounts are in Wicomico and Allegany counties.


The revenue trend for most county governments still points upward, with general fund revenues increasing statewide by 0.9% in fiscal 2021 compared to a 2.4% growth rate in fiscal 2020. Over a two-year period, local general fund revenues are expected to increase by \$529.2 million, from \$15.9 billion in fiscal 2019 to \$16.4 billion in fiscal 2021. This represents a 1.6% average annual increase over the two-year period.

Six jurisdictions are anticipating a decrease in general fund revenues over the two-year period. In the other counties, the average-annual increase ranges from 0.2% in Allegany and Wicomico counties to 5.5% in Dorchester County. Two counties are expecting average annual increases of 5% or greater, while six counties are expecting increases between 2% and 5%.


#### **Local Tax Revenues**

The projected growth in local tax revenues, which includes both general and special fund revenues, is projected to slow, with local revenues increasing by 1.6% in fiscal 2021, compared to 3.3% in fiscal 2020. The average annual increase in local tax revenues over the two-year period is projected at 2.5%. In total, local governments are projected to collect \$16.6 billion in local tax revenues, a \$789.7 million increase since fiscal 2019.


Statewide, local tax revenues average \$2,750 per capita. The highest per capita amounts are in Howard, Montgomery, Worcester, and Calvert counties, where local tax revenues exceed \$3,000 per capita. The lowest per capita amounts are in Somerset, Allegany, Wicomico, and Caroline counties, where local tax revenues are below \$1,500 per capita.

Most jurisdictions are realizing average annual increases in local tax revenues of between 1% and 4%. Only Anne Arundel County is anticipating increases in excess of 4%, while three counties (Baltimore City, Garrett, and Washington) are anticipating increases below 1%. Five counties anticipate a decrease in local tax revenues over the two-year period. Declines in total local tax revenues are driven primarily by declines in income tax collections due to higher unemployment. Additionally, revenues from other local taxes have declined due to the decreased economic activity and restrictions put in place to combat the pandemic.


### **Property Taxes**

Due to the triennial assessment process and the homestead assessment caps, the property tax remains a relatively stable and predictable revenue source for county governments. Revenue collections are projected to total \$9.1 billion in fiscal 2021. This represents a \$564.8 million increase over a two-year period.


Property tax collections are affected by each jurisdiction's tax rate and assessable base amount. For fiscal 2021, three counties – Anne Arundel, Calvert, and Wicomico – decreased real property tax rates, while Montgomery County slightly increased rates. Real property tax rates range from \$0.6372 per \$100 of assessed value in Talbot County to \$2.248 in Baltimore City.

The larger the assessable property tax base in a county, the more revenue that can be derived with an increase in the property tax rate. For example, a one-cent increase in the real property tax rate in Talbot County for fiscal 2021 generates approximately \$742,900, whereas it generates only \$136,700 in Somerset County, even though the jurisdictions have a comparable number of residents. County assessable base in fiscal 2021 totals \$810.8 billion or \$134,116 per State resident. Per capita assessable base ranges from \$55,143 in Allegany County to \$320,516 in Worcester County.

# Property Tax Revenue – County Tax Rates FY2021




Statewide, local property tax revenues average \$1,498 per capita. The highest per capita amounts are in Worcester, Howard, and Calvert counties, where local tax revenues exceed \$2,000 per capita. The lowest per capita amounts are in Allegany, Wicomico, and Somerset counties, where local property tax revenues are below \$700.


For the most part, the increase in county property tax revenue is driven by the growth in the jurisdiction's property tax base. Based on projections by the State Department of Assessments and Taxation, the county assessable base will increase by 2.2% in fiscal 2021, a decrease from the 3.5% growth rate in fiscal 2020. Although just over half of counties are projected to realize growth rates of over 2%, several counties are projected to experience growth rates of 1% or less, which could constrain revenue growth.

The average annual increase in local property tax revenues over the prior two-year period ranges from 0.9% in Somerset County to 5.6% in Anne Arundel County. Allegany County is the only jurisdiction anticipating a decrease in property tax revenues over the two year period. However, five counties are experiencing annual increases of less than 2% a year; while six counties are experiencing growth rates of 4% or higher.

#### **Income Taxes**


In an effort to reduce reliance on the local property tax, legislation was enacted in 1967 authorizing local governments to impose a local personal income tax. Today, the local income tax is the third largest revenue source for county governments, accounting for 17.5% of total revenue in fiscal 2019. Maryland is one of the few states in the nation that allow local governments to impose a local income tax.

Local governments are authorized to set a local income tax rate of at least 1.0% but not more than 3.2%. Currently, 12 jurisdictions impose the maximum local income tax rate, with five of the jurisdictions located in the Washington-Baltimore corridor, six jurisdictions located on the Eastern Shore, and one jurisdiction located in Western Maryland.


In calendar 2021, no county altered its local income tax rate. However, in calendar 2020, seven counties increased their local income tax rate, with four of the counties raising the rate to the maximum amount.

Net taxable income is the tax base used in determining local income tax liability. Montgomery and Howard counties lead the State in per capita net taxable income followed by Talbot and Anne Arundel counties. Somerset County has the lowest per capita net taxable income, followed by Allegany, Dorchester, and Wicomico counties.

#### Income Tax Revenue – Per Capita Net Taxable Income Tax Year 2018




# Income Tax Revenue – County Tax Rates CY2021




Local income tax revenues are projected to total \$5.9 billion in fiscal 2021. This represents a \$309.5 million increase over a two-year period. Statewide, local income tax revenues average \$984 per capita. The highest per capita amounts are in Montgomery and Howard counties, where local tax revenues exceed \$1,400 per capita. The lowest per capita amounts are in Somerset, Allegany, and Garrett counties, where local income tax revenues are below \$500.

The average annual increase in local income tax revenues over the prior two-year period ranges from 0.2% in Howard County to 8.4% in Dorchester County. However, ten counties are experiencing a decrease in local income tax revenues over the two-year period, and four counties are experiencing annual growth rates below 2%. Eight counties realize growth rates of 5% or higher.

#### **Recordation Taxes**


Recordation taxes continue to be an important revenue source for local governments, with anticipated revenues totaling \$484.7 million in fiscal 2021. Between fiscal 2019 and 2021, recordation tax revenue is projected to decrease by \$35.9 million representing a 3.5% annual decrease over the two-year period.

Recordation tax collections reached a peak of \$619.0 million in fiscal 2006 which coincided with the soaring real estate market. Revenues declined to \$237.9 million in fiscal 2010. Since that time, local recordation taxes have increased at an average annual rate of 6.7%. More recently, in the past five years, the average annual increase has totaled 2.5%.


In fiscal 2021, recordation tax revenue projections range from \$700,000 in Somerset County to \$162.8 million in Montgomery County. On a per capita basis, estimated revenue collections range from \$20 in Allegany County to \$173 in Frederick County. Revenue collections tend to be higher in jurisdictions with higher home prices and home sales.

No county altered its recordation tax rate for fiscal 2021. Recordation tax rates range from \$2.50 per \$500 of transaction in Baltimore and Howard counties to \$6.00 per \$500 of transaction in Frederick and Talbot counties. A majority of counties have tax rates set between \$3.00 and \$5.00.

#### **Transfer Taxes**


Local transfer tax revenues are projected to total \$473.8 million in fiscal 2021. The current revenue projection is below the amount collected by local governments in fiscal 2019. Between fiscal 2019 and 2021, transfer tax revenue is projected to decrease by \$26.2 million. This represents a 2.7% annual decrease over the two-year period.

Due to the volatility in home sales and the potential for a slowdown in the real estate market, many local governments have taken a conservative approach in developing their revenue estimates for the transfer tax. Actual revenue collections have increased at an average annual rate of 7.3% in the past five years (fiscal 2014 to fiscal 2019).


In fiscal 2021, transfer tax revenue projections range from \$500,000 in Caroline County to \$122.9 million in Prince George's County. On a per capita basis, estimated revenue collections range from \$8 in Allegany County to \$135 in Prince George's County.

Howard County increased its local transfer tax rate for fiscal 2021 from 1.0% to 1.25%. Local transfer tax rates range from 0.5% in eight counties (Allegany, Caroline, Cecil, Charles, Kent, Queen Anne's, Washington, and Worcester) to 1.5% in Baltimore City and Baltimore County. Five counties (Calvert, Carroll, Frederick, Somerset, and Wicomico) do not impose a tax on property transfers.

#### **Hotel Rental Taxes**


Hotel rental taxes are imposed in all counties in Maryland. In several jurisdictions, revenues collected from the hotel rental tax are shared with municipalities and community organizations. A few municipalities are also authorized to impose a hotel rental tax or to collect the county tax within their jurisdiction.

In fiscal 2021, county governments will collect \$75.5 million in revenue from the hotel rental tax. This represents a \$5.3 million decrease from the amount collected in fiscal 2019. The amounts range from \$60,000 in Somerset County to \$23.3 million in Montgomery County. On a per capita basis, hotel rental tax revenue ranges from \$2 in Cecil County to \$88 in Garrett County. Caroline County did not report any revenues from the hotel rental tax.


Baltimore City will collect \$21.3 million in hotel rental taxes in fiscal 2021, an \$11.7 million decrease from fiscal 2019.

No county altered its hotel rental tax rate for fiscal 2021. Effective January 1, 2020, Worcester County increased its local hotel rental tax rate from 4.5% to 5%. Hotel rental tax rates currently range from 4% in Talbot County to 9.5% in Baltimore City and Baltimore County. Tax rates are higher in the Washington-Baltimore corridor and in Western Maryland. The Eastern Shore and Southern Maryland tend to have the lowest tax rates.


#### **Admissions-Amusement Taxes**

County governments and Baltimore City are projecting to collect \$35.8 million in admissions and amusement tax revenue in fiscal 2021. Between fiscal 2019 and 2021, admissions and amusement tax revenues are projected to decrease by \$10.0 million. This represents an 11.6% annual decrease over the two-year period.


In fiscal 2021, admissions and amusement tax collections range from \$500 in Dorchester County to \$9.9 million in Prince George's County. On average, county governments collected \$6 per capita in admissions and amusement tax revenue. Garrett County leads the State with per capita admissions and amusement tax revenue totaling \$26.

No county altered its admissions and amusement tax rate for fiscal 2021. Caroline and Frederick counties are the only jurisdictions that do not impose an admissions and amusement tax. Currently, admissions and amusement tax rates range from 0.5% in Dorchester County to 10.0% in six jurisdictions – Baltimore City and Anne Arundel, Baltimore, Carroll, Charles, and Prince George's counties.

#### **Other Local Taxes**


Many county governments, including Baltimore City, impose a variety of other local taxes including sales and service taxes. Counties are generally limited to imposing sales taxes on fuels and utilities. Worcester County is authorized to impose a sales tax on food and beverages in Ocean City. Montgomery County imposes a tax on E-cigarettes and certain plastic bags. Baltimore City and Anne Arundel County imposes a tax on parking facilities.

In fiscal 2021, county governments are estimated to collect \$530.4 million in other local taxes. Sales taxes on energy sources account for 65.6% of the other local taxes (\$348.0 million) while sales taxes on telephones account for 23.9% of the total (\$126.6 million).

In fiscal 2021, revenues from other local taxes range from \$50,000 in Charles and Talbot counties to \$249.3 million in Montgomery County. On average, county governments collected \$88 per capita in other local taxes. Montgomery County leads the State with per capita collections totaling \$237, followed by Baltimore City (\$203). Prince George's County had per capita collections exceeding \$100.

Between fiscal 2019 and 2021, revenues from other local taxes are projected to increase by \$4.6 million. This represents a 0.4% average annual increase over the two-year period.
