

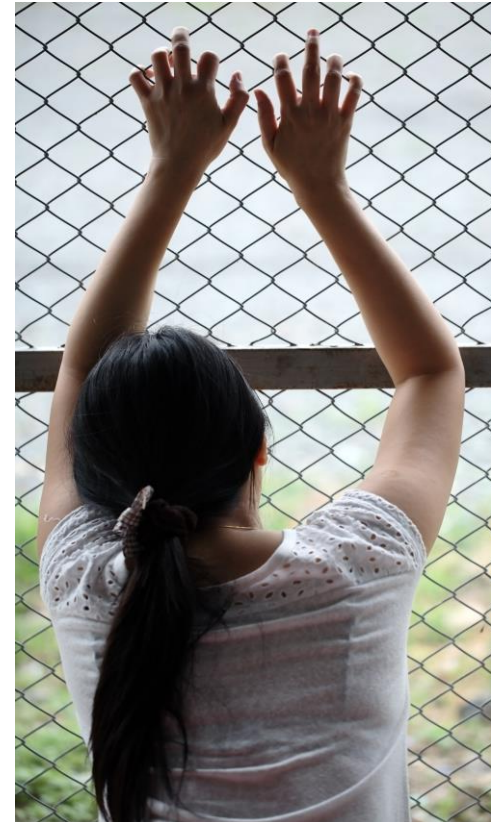
WHAT IS “AT RISK”? Under Maryland Education Article §8-701

“At risk youth” means an individual who meets at least two of the eligibility criteria determined by the Department and an operator that may include: (1) Being eligible for free or reduced price meals; (2) A record of suspensions, office referrals, or chronic truancy; (3) A failure to achieve a proficient or advanced level on State assessments in reading or mathematics, or both; (4) Having a disability; (5) A referral from a teacher, counselor, social worker, or community based service organization; (6) The head of household is a single parent; (7) The head of household is not a custodial parent; (8) The adjusted gross family income is below the federally established poverty guidelines; (9) The family receives temporary cash assistance under the State Family Investment Program; or (10) A member of the family has been incarcerated.

The State has identified schools that are “at risk” and has defined those as “schools where 61% or more of students earn a performance level of one or two on the state assessment for mathematics or English language arts (ELA).”¹ For example, of the 38 high schools that are considered *at risk*, 22 are in Baltimore City and 11 are in PG County. This number is alarming, especially since in PG County approximately 90% of the student population is either African-American or Latino.² Baltimore City has nearly the same percentage with approximately 80% being African American and roughly 10 percent Latino.

Generally speaking, however, the term *at-risk* is often used to describe students or groups of students who are considered to have a higher probability of failing academically or dropping out of school.ⁱ The term may be applied to students who face circumstances that could jeopardize their ability to complete school, such as homelessness, incarceration, teenage pregnancy, low test scores, disciplinary problems, grade retentions, or other learning-related factors that could adversely affect the educational performance and attainment of some students.ⁱⁱ

Under federal law, unless a participating school is operating a schoolwide program, the school must focus Title I services on children who are failing, or most *at risk of failing*, to meet State academic standards.



Most of our “at risk” students attend school in Baltimore City and/or PG County; they are also African-American & Latino.
