





- Casino Gaming
  - Regulated by the State Lottery and Gaming Control Agency (SLGCA) with MLGCC
- Horse Racing/Off-track Betting (OTB)
  - Regulated by the State Racing Commission
- Commercial Bingo
  - Regulated by local governments and SLCGA




## Horse Racing and OTBs




## **Commercial Bingo**

- 13 locations in two counties
  - Anne Arundel County 9 locations
  - Calvert County 4 locations
- Only 2 locations authorized to have 200 machines
  - Bingo World Anne Arundel County
  - Rod 'N' Reel Calvert County



# Overview of Chapter 356 of 2021

- Chapter 356 governs the implementation of sports wagering in the State
- An individual at least 21 years old may wager on certain events
- Three types of sports wagering licenses are authorized
  - Class A Sports Wagering Licenses physical facility
  - Class B Sports Wagering Licenses physical facility
  - Mobile Sports Wagering Licenses web/internet based
- All the Class A and 7 Class B licenses are designated/named by law
- Subject to certain restrictions, SWARC is authorized to award up to
  - 30 Class B Sports Wagering Licenses (in addition to the 7 designated by law)
  - 60 Mobile Sports Wagering Licenses




# Class A Sports Wagering Licenses

#### Class A-1 License

- Three casinos with over 1,000 VLTs
  - Horseshoe Casino
  - Live! Casino
  - MGM
- Three stadiums/professional sports teams
  - Oriole Park
  - M&T Bank Stadium
  - FedEx Field
- Application fee is \$2 million


#### Class A-2 License

- Three casinos with fewer than 1,000 VLTs
  - Hollywood Casino
  - Ocean Downs Casino
  - Rocky Gap Casino Resort
- One Laurel/Pimlico License
- Application fee is \$1 million



# Class B Designated Sports Wagering Licenses

- Seven designated Class B licenses
  - State Fairgrounds
  - Four OTB locations
    - Greenmount Station
    - The Jockey Bar and Grille
    - Long Shot's
    - Riverboat on the Potomac
  - Two commercial bingo facilities with at least 200 machines
    - Bingo World
    - Rod 'N' Reel



## Class B Sports Wagering Licenses


#### Class B-1 Licenses

- Class B with more than: Class B with less than:
  - 25 or more employees; or
    25 employees; or
  - \$3 million in gross receipts
- Application fee is \$250,000
   Application fee is \$50,000


  - \$3 million in gross receipts



# Mobile Sports Wagering Licenses

 Subject to certain requirements, SWARC may award up to 60 mobile sports wagering licenses

Application fee is \$500,000




### MLGCC vs. SWARC

### **MLGCC**

- Regulation of the operation of sports wagering
- Licensing of industry participants
- Issuance of the Sports Wagering License
- License Renewal Process


#### **SWARC**

- Establishes the license application process
- Awards all sports wagering licenses
  - Determines that awarding an applicant a license is in the public interest
  - MOU with licensee regarding future investors
- Special considerations for Class B and Mobile licenses
- Ensures when awarding each license that the exclusion zone is maintained




# SWARC – Class B and Mobile Licenses

- Actively seek to achieve racial, ethnic, and gender diversity when awarding licenses
- Encourage applicants who qualify as a minority business enterprise or who are small, minority-, or women-owned business entities to apply for sports wagering licenses




# **SWARC – Class B and Mobile Licenses – Activities**

- Evaluate a study of the sports wagering industry to determine whether there is a compelling interest to implement remedial measures to assist minorities and women in the sports wagering industry
  - The study will be the subject of a future SWARC meeting
- Evaluate race-neutral programs to address the needs of minorities, women, and minority- and women-owned businesses seeking to participate in the sports wagering industry, including through ownership of licensed sports wagering entities
- If remedial measures are necessary, SWARC must adopt regulations to implement the remedial measures



# SWARC – Class B and Mobile Licenses


- Consider as a factor for awarding a license whether an applicant for a Class B license intends to conduct sports wagering at a facility located in an opportunity zone or an enterprise zone
- Consider allowing early access to the mobile sports wagering market to entities with a meaningful partnership with minorities, women, and minority- and women-owned businesses



### **Exclusion Zones**

 A license may not be awarded to a licensee for a location within


- a 15 mile radius of Hollywood Casino, Ocean Downs Casino, and Rocky Gap Casino
- a 1.5 mile radius of any other Class A or B licensee









## **Designated Locations – Map**






### **Designated Locations – Map**






## **Transferability**

A Class B and Mobile licensee may not transfer ownership of a license unless the licensee has been actively engaged in operating sports wagering in the State for at least three years



### **Timeline of Events**

- Begin awarding licenses to applicants designated in law and approved by Lottery
- Evaluate a study of the sports wagering industry to determine if there is a compelling interest to implement remedial measures to assist minorities and women
- Adopt regulations providing for a scoring system for competitive licenses
- Competitive Class B license applications submitted
- Competitive Class B licenses awarded
- Competitive Mobile license applications submitted
- Competitive Mobile licenses awarded
