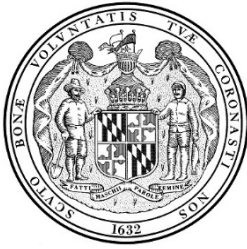

# **Collateral Consequences of a Criminal Conviction**

---

## **The Felony/Misdemeanor Distinction**

The distinction between a felony and a misdemeanor has changed over time and differs among jurisdictions. Under English common law a felony was an offense for which the penalty involved forfeiture in addition to any other punishment. Today, under federal law and the law of many states, a felony is a crime for which the punishment is death or imprisonment for more than one year. In Maryland and several other states, a felony is a crime declared to be so by the common law or by statute, regardless of the punishment that may be imposed. See **Appendix 1** for a list of the statutory felonies in the State. Under Maryland law, certain misdemeanors may carry harsher penalties than certain felonies.

## **Collateral Consequences of Conviction**

When considering the State or federal collateral consequences of a conviction, it is important to note whether the consequence is tied to the categorization of the offense as a felony as opposed to a misdemeanor, the sentence that is or could be imposed, the nature of the crime itself, or some combination of these factors. For example, certain punitive collateral consequences may attach to theft crimes or crimes of violence regardless of whether the offense is a felony or a misdemeanor. Consequences may attach to felonies of a certain category such as drug crimes. Often, the fact that an offense is a felony is not a deciding factor in whether a particular collateral consequence will apply.

## **Maryland Law**

Many collateral consequences of a conviction under Maryland law are in the areas of voting rights, jury service, firearms, licensing and employment, and alcoholic beverage licenses.

### **Voting Rights**

Under § 3-102 (b) of the Election Law Article, an individual is not qualified to be a registered voter if the individual “has been convicted of a felony and is currently serving a court-ordered sentence of imprisonment for the conviction.” Chapter 734 of 2021 requires that the Department of Public Safety and Correctional Services provide every individual who is released from a correctional facility with a voter registration application and documentation with the individual’s discharge papers that informs the individual that the individual’s voting rights have been restored.



The department is also required to post notice that any individual who is no longer incarcerated has the right to vote at all parole and probation offices and on the department's website. Chapter 159 of 2007 repealed a provision that permanently disqualified all individuals who had ever been convicted of a felony from voting.

## Jury Service

For jury service, the categorization of an offense as a felony or misdemeanor is not relevant. The determining factor is the length of an imposed or possible sentence. Under § 8-103 of the Courts and Judicial Proceedings Article, an individual is not qualified for jury service if the individual:

- has been convicted, in a federal or State court of record, of a crime punishable by imprisonment exceeding 1 year and received a sentence of imprisonment for more than one year; or
- has a charge pending, in a federal or State court of record, for a crime punishable by imprisonment exceeding one year.

In most states, juror disqualification is limited to circumstances in which there has been a *felony* conviction, but there are exceptions. For example, Texas also disqualifies individuals who have a misdemeanor theft conviction; Oregon statute prohibits any individual who has had a conviction for a misdemeanor involving violence or dishonesty within five years from serving on certain types of juries. Pennsylvania and South Carolina are similar to Maryland and federal law, as ineligibility for juror service in those states is triggered by the length of the sentence and not whether the offense is a felony or misdemeanor. Only three states (Illinois, Iowa, and Maine) do not automatically disqualify jurors based on a past felony conviction. In Colorado, although a felony conviction disqualifies a *grand* juror, it does not render a *trial* juror ineligible for service. However, all states exclude individuals who are currently incarcerated from jury service.

States also differ in the duration of exclusions due to a criminal conviction. Approximately half of the states (and the District of Columbia) that exclude jurors because of criminal convictions do so for a limited amount of time. In general, the exclusions are for a specified time period after the conviction occurs or until the terms of the sentence, often including any parole and/or probation, have been completed. Indiana and North Dakota, however, only exclude jurors with felony convictions from jury service during any period of actual incarceration. In the remaining states, jurors with specified criminal convictions are generally permanently prohibited from serving on juries. Although in some of these states, including Maryland, an individual may regain the ability to serve as a juror in limited circumstances (such as if a pardon is granted), the rarity of these circumstances still effectively creates a permanent disqualification in most instances.

Maryland is also one of at least seven states (along with Connecticut, Florida, Kentucky, Louisiana, Massachusetts, and Texas) in which pending charges disqualify an individual from jury service. This is also the practice in the District of Columbia and, as noted above, in the federal courts.

## **Firearms**

Section 5-133 of the Public Safety Article prohibits a person from possessing a regulated firearm if the person has been convicted of a “disqualifying crime”. A “disqualifying crime” means a felony, a crime of violence, or a misdemeanor in the State that carries a penalty of more than two years and includes probation before judgment for a crime of violence and for certain domestically related crimes as specified in § 6-233 of the Criminal Procedure Article. A “regulated firearm” is defined as a handgun or any of a long list of assault weapons or their copies (Public Safety § 5-101). Possession of ammunition, rifles, and shotguns are also prohibited by a person convicted of a disqualifying crime. See **Appendix 2** for a list of State firearms consequences for conviction.

## **Licensing and Employment**

Criminal convictions carry a variety of collateral consequences related to employment and licensing. There are few provisions that prohibit employment outright solely on the basis of a felony conviction.

A large number of statutes authorize the refusal, suspension, or revocation of a professional license for individuals who have been convicted of felonies. In addition to felony convictions, these statutes usually authorize adverse licensing decisions for individuals whose convictions fall under particular categories of crimes such as a sex offense, a violent offense, or a drug offense, that is relevant to the field of employment. See **Appendix 3** for a complete listing of business and professional licensure felony conviction restrictions.

Additionally, statutorily required and optional background checks may also act as collateral sanctions of conviction. Evidence of a felony conviction discovered during a background check of a job applicant may lead to the denial of a position that would have been offered had the conviction been for a misdemeanor.

State appointing authorities in the Executive, Legislative, or Judicial branches are generally prohibited from inquiring into the criminal record or history of an applicant for employment until the applicant has been given an opportunity for an interview. However, exemptions exist for the Department of Public Safety and Correctional Services, any position for which an appointing authority is required by law to conduct a criminal history records check, any position in the sheriff’s office of any county (with respect to constitutional obligations), or any position within the State Personnel Management System exempted by the Secretary of Budget and Management.

An appointing authority may still notify an applicant that prior criminal convictions may prohibit employment for some positions.

## **Federal Law**

Certain federal benefits may be revoked, refused, or limited upon conviction of a crime. However, it is usually the type of crime committed that is determinative, not its distinction as a felony. For instance, conviction under certain controlled dangerous substance laws may bar a person from receiving food stamps or temporary assistance for needy families (21 U.S.C. § 862) (While Maryland has exercised its right to partially opt out of this prohibition, it has retained the right to deny benefits for certain drug offenses. Md. Code, Human Services § 5-601(b)). Conviction of certain drug crimes may also disqualify a student from receiving grants, loans, or work assistance (20 U.S.C. § 1091). Another example is that a person who is subject to a lifetime registration requirement under a state sex offender registration program is ineligible for federally assisted housing (42 U.S.C. § 13663).

As with State law, ineligibility for federal jury service is triggered by the length of the maximum sentence possible for a conviction for the offense. Under 28 U.S.C. § 1865, a person is not qualified for jury service if the person “has a charge pending against him for the commission of, or has been convicted in a State or Federal court of record of, a crime punishable by imprisonment for more than one year.”

Under 18 U.S.C. § 922(g), it is unlawful to an person who “has been convicted in any court of a crime punishable by imprisonment for a term exceeding one year ... or who has been convicted in any court of a misdemeanor crime of domestic violence ... to ship or transport in interstate commerce, or possess in or affecting commerce, any firearm or ammunition; or to receive any firearm or ammunition which has been shipped or transported in interstate or foreign commerce.” Again, it is the length of a possible sentence that triggers the prohibition, not a distinction as a felony. Under the federal law, individuals who have been convicted in any court of a misdemeanor crime of domestic violence are also prohibited from possessing firearms.

With respect to federal employment, a felony conviction often does not disqualify a person, but it may be considered in connection with determining suitability for employment.

Military service is an area where conviction of a felony is determinative. Under 28 U.S.C. § 1865, a person “who has been convicted of a felony, may not be enlisted in any armed force.” Additionally, a felony conviction requires automatic discharge from employment in federal law enforcement (5 U.S.C. § 7371) and employment related to securities and federal financial institutions, for example the Federal Deposit Insurance Corporation, may be barred for a felony conviction (12 C.F.R. 336.4). See **Appendix 4** for a list of mandatory/automatic collateral consequences under federal law for any felony conviction.

For an in-depth examination of all federal consequences for a conviction as well as information on the collateral consequences of conviction in other states, [the National Inventory of Collateral Consequences of Conviction](#) maintains the Collateral Consequences Inventory, which is an extensive searchable database of information nationwide.
