**Principal Duties:** The Legislative Fellows Program offers top graduate students in the Maryland, DC, Virginia, region an immersive experience in the legislative process. Fellows work alongside nonpartisan staff within the Department of Legislative Services (DLS), the professional staff agency for the Maryland General Assembly (MGA) during the General Assembly's annual 90-day legislative session (Jan – April). Duties include and assisting legal, fiscal and committee staff with their regular session duties. Fellows must be available to work in Annapolis for a minimum of 20 hrs. per week.

Fellows will be assigned to work alongside staff within General Assembly committee, caucus, delegation and leadership offices as well as the Office of Policy Analysis (OPA). While work duties may vary depending on the specific job assignment, fellows will generally be involved in legal, fiscal and policy research and analysis as well as responding to legislative requests and producing publication content. All work assignments require strong writing and analytical skills.

**Qualifications (vary by function):** The Fellows Program is specifically designed for graduate students at Maryland and other regional institutions (i.e. Virginia and Washington DC.) offering master's degrees in public policy as well as law students.

Graduate students with a demonstrated interest in pursuing a career in legislative / public policy work should consider the legislative fellowship. Applicants must have strong writing and analytical skills and a G.P.A. of 3.0 or higher.

\*\* The total stipend varies, depending on the number of weeks a Fellow serves. Hiring periods begin in November, December and January and depend on the hiring unit's preference. Please note, all stipends are taxable income and paid in installments throughout the term. The stipend amounts are listed below:
