





## Youth Apprenticeship Curriculum – 120 hours Proposed

Business and Finance Foundational Level – 35 hrs.

- Intro to Business and Finance
- Inro to Management Accounting
- Intro to Financial Accounting

One part of the Operational Level as selected by employer but allow access to all - 35 Hours

- Digital Finance (35 hrs.)
- Management Accounting (35 hrs.)
- Financial Reporting and Tax (35 hrs.)

MACPA Student Leadership Academy – 16 hrs.

- 2-day program that teaches success skills and intro to the profession; introduces students to accountants

Think Like an Entrepreneur – 22 hrs.

## Status of AICPA Program in Maryland after 12 mos

AICPA's apprenticeship program has been very well received by employers of all sizes, after an initial period to educate on apprenticeships

9 Employers registered or are under contract about to be registered, including major employers Marriott, Stanley Black and Decker and CareFirst covering about 60 apprentices.

7 Additional employers are in negotiation

AICPA began discussions about youth apprenticeships last week with employers
