Legend of Terms:								
Term	Definition or Description							
Accounts	Administration accounts filed periodically by personal representatives, special administrators, or guardians.							
Claims	Claims of creditors against decedents' estates filed with the Register of Wills.							
Disbursements	Disbursements made by the Registers of Wills including, for example, refunds to personal representatives for overpayment of probate fees.							
Docket Entries	Each document filed in each proceeding in the Register of Wills is made part of the estate docket, which includes coding the docket entry, entering the name of the document, and digitally imaging the document.							
Guardianship Show Cause Hearing	Ahearing held before an Orphans' Court when a guardian has failed to timely file an annual account or upon petition by an interested person for the guardian's removal.							
Hearings Held by Court	Any hearing held before an Orphans' Court that is not a show cause hearing. This includes, for example, hearings on petitions to allow claims after the personal representative has disallowed the claim, petitions for counsel fees and objections to those petitions, exceptions or objections to administration accounts, etc.							
Hearings Scheduled	Hearings scheduled, including those later canceled.							
Invoices	Invoices issued by the Register of Wills for payment of inheritance tax, probate fees, or other fees.							
New Contacts	Each interested person and unpaid creditor is entered into the Registers' estate case management system for the purposes of ensuring they receive notice of all orders issued by the Orphans' Courts.							
New Proceedings	All new proceedings opened in the Registers of Wills, including small and regular estates, judicial small and regular estates, estates that proceed under Modified Administration, ancillary probate proceedings, Wills of No Estate, guardianship estates, and non-probate matters.							
Orders Issued	Orders signed by the Orphans' Courts, which are docketed and mailed to interested persons by the Registers of Wills.							
Receipts	Receipts issued by the Registers of Wills for payment of fees and taxes.							
Registered Domestic Partnerships	The Registers of Wills issue Certificates of Domestic Partnership to qualifying applicants exempting partners from the inheritance tax and providing a surviving partner who dies without a will benefits similar to a surviving spouse.							
Show Cause for Removal Hearing	Ahearing held before an Orphans' Court when a personal representative or special administrator has failed or allegedly failed in their duties to the extent an Orphans' Court deems it necessary to consider removing them from the estate. These hearings may be held on a court's own initiative or upon petition by an interested person.							
Show Cause Hearing	Ahearing held before an Orphans' Court when a personal representative or special administrator has failed to meet some legal requirement, such as failing to timely file an Information Report, Inventory, or Administration Account.							
Wills Received	Wills filed by members of the public with the Registers of Wills for safekeeping.							
Wills Removed	Registers of Wills retriving wills from safekeeping storage and returning them to the testator or their attorney, or removed to open the testator's estate.
